ORDINANCE NO. 2017-28 A

AN ORDINANCE AMENDING CERTAIN PROVISIONS OF THE VILLAGE OF MAPLE PARK'S LIQUOR CONTROL ORDINANCE (ARTICLE 4, CHAPTER 2, SECTION 16, "HOURS OF OPERATION," OF THE MAPLE PARK VILLAGE CODE)

BE IT ORDAINED by the President and Board of Trustees of the Village of Maple Park, Illinois as follows:

**Section One:** That Title 4, "Business and License Administration," Section 2, "Liquor Control," shall be modified by adding subsection A.3 to Section 4-2-16, as follows:

3. Notwithstanding the specific day of the week, which may otherwise control hours of operation, licensees may conduct business on New Year's Eve until two o'clock (2:00) a.m. of the following day.

**Section Two:** That all ordinances and parts of ordinances in conflict or inconsistent with the provisions of this ordinances are hereby repealed to the extent of any such conflict or inconsistency, and that if any part or portion of this ordinance shall be declared invalid by a court of competent jurisdiction, such partial invalidity shall not affect the remainder of this ordinance.

**Section Three:** That this ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as hereby authorized to be done by the President and Board of Trustees.
