GOLF CARTS

DUE BY MAY 31, AT A COST OF \$15.00 EACH

- Please complete the enclosed application and return it to the village office by May 31st to avoid the late fee of \$10.00 per golf cart.
- Every golf cart in the Village of Maple Park will need pass an inspection and be registered before a sticker is issued.
- Golf carts will be inspected and approved by the Chief of Police or a designee at the time of application.

All persons operating a golf cart or a utility terrain vehicle on the streets under the jurisdiction of the Village of Maple Park must ensure compliance with the following requirements:

- A. Proof of Liability Insurance
- B. Driver's License: Driver must have current valid government issued driver's license.
- C. Age Requirement: Driver must be of the age of eighteen (18).
- D. All golf carts and utility terrain vehicles must be registered with the Village of Maple Park and proof of such registration shall be displayed and visible on the rear of the vehicle.
- E. Required Equipment: Golf carts and utility terrain vehicles must be equipped as follows:
 1. Brakes and brake lights;
 2. A steering wheel apparatus;
 3. Tires;
 4. Rearview mirror;
 5. Approved "slow moving vehicle" emblem on the rear of the vehicle;
 6. Headlight that emits a white light visible from a distance of five hundred feet (500') to the front of which must be illuminated when in operation;
 7. Taillamp that emits a red light visible from a distance of at least one hundred feet (100') from the rear which must be illuminated when in operation;
 8. Any additional requirements which may be required by 625 Illinois Compiled Statutes 5/11-1426.1, as amended.
- F. Occupants: The maximum number of occupants in such vehicles shall be deemed to correspond with the total number of seats available on the particular vehicle.
- G. Golf Carts and Utility Terrain Vehicles require proper seating equipment for infants, and children must meet the minimum requirements of the Compiled Statutes of the Illinois State Vehicle Code (no exceptions). <http://www.ilga.gov/legislation/ilcs/fulltext.asp?DocName=062500050K11-1426.1>

RELEASE OF LIABILITY, WAIVER, DISCHARGE, AND COVENANT NOT TO SUE

In connection with the issuance of a golf cart permit by the Village of Maple Park (“Village”), the undersigned (“Operator”) represents and agrees as follows:

I FULLY RECOGNIZE THAT THERE ARE DANGERS AND RISKS TO WHICH I MAY BE EXPOSED BY OPERATING A GOLF CART ON VILLAGE STREETS, INCLUDING BUT NOT LIMITED TO: INJURY TO MYSELF OR OTHERS. IN NO EVENT SHALL THE VILLAGE BE LIABLE FOR DIRECT, INDIRECT, SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES, WHETHER ARISING IN TORT, CONTRACT OR ANY OTHER LEGAL THEORY, IN CONNECTION WITH OR ARISING OUT OF OPERATOR’S USE OF A GOLF CART ON VILLAGE STREETS. I WILL SAVE, HOLD HARMLESS, AND INDEMNIFY THE VILLAGE AGAINST ANY AND ALL LIABILITY, CLAIMS, CAUSES OF ACTION, AND COSTS OF WHATSOEVER KIND AND NATURE INCLUDING, WITHOUT BEING LIMITED TO INJURY, DAMAGE, LOSS – INCLUDING DEATH, RESULTING FROM, ARISING OUT OF OR OCCURRING IN CONNECTION WITH MY USE OF THIS GOLF CART ON VILLAGE STREETS.

I understand that Section 7-11-1 through 7-11-6 of the village code govern the use of qualified golf carts on village streets and hereby agree to conform with all requirements of the village code and the traffic laws of the State of Illinois at all times.

I, THEREFORE, AGREE TO ASSUME AND TAKE ON MYSELF ALL OF THE RISKS AND RESPONSIBILITIES IN ANY WAY ASSOCIATED WITH THIS ACTIVITY. IN CONSIDERATION OF AND RETURN THE OPPORTUNITY TO OPERATE A GOLF CART ON VILLAGE STREETS, I RELEASE THE VILLAGE AND ITS ELECTED AND APPOINTED OFFICERS, ITS EMPLOYEES, AND ITS AGENTS, FROM ANY AND ALL LIABILITY, CLAIMS AND ACTIONS, THAT MAY ARISE FROM INJURY OR HARM TO OTHERS IN CONNECTION WITH THIS ACTIVITY. THIS RELEASE ALSO COVERS LIABILITY, CLAIMS AND ACTIONS CAUSED ENTIRELY OR IN PART BY ANY ACTS OR FAILURES TO ACT, INCLUDING BUT NOT LIMITED TO NEGLIGENCE, MISTAKE, OR FAILURE TO ENFORCE, SUPERVISE OR MAINTAIN, AND INCLUDING THE OPERATION OF MY VEHICLE BY ANY OTHER PERSON OTHER THAN MYSELF.

FURTHERMORE, I ASSURE THE VILLAGE that there are no health-related reasons or problems with preclude or restrict my participation in this activity. I further assure the village that I have adequate health and liability insurance necessary to provide for any pay and medical costs or property damage directly or indirectly resulting from my participation in this activity, and I will indemnify and hold the village harmless for any such medical costs or property damage. I understand that this Release means that I am giving up, among other things, the right to sue the Village, its Board of Trustees, employees, and agents for injuries (including death), damages, or losses I may incur or cause. I also understand that the Release binds my heirs, executors, administrators, and assigns, as well as myself.

I HAVE READ AND FULLY UNDERSTAND THIS ENTIRE RELEASE, AND I AGREE TO BE LEGALLY BOUND BY IT.
