**A RESOLUTION APPROVING SPECIAL EVENTS PERMIT
2022-02 “TOUR DE FARMS BIKE EVENT”**

WHEREAS, the Village of Maple Park (Village) is a non-home rule municipality in accordance with the Constitution of the State of Illinois of 1970; and,

WHEREAS, the National Multiple Sclerosis Society is hosting the Tour De Farms Bike Event on Saturday, June 25, 2022; and,

WHEREAS, the National Multiple Sclerosis Society will conduct the Bike Event between 7:00 a.m. and 1:00 p.m. with the clean-up taking place after the event; and,

WHEREAS, in approving the National Multiple Sclerosis Society’s request this Board’s action allow for a rest stop located at the McAdams Pavilion in the Village of Maple Park, as indicated on Exhibit A; and,

WHEREAS, the logistics of the event will be the responsibility of the National Multiple Sclerosis Society; as well as the responsibility for clean-up of the area after the event.

SECTION 1. To the fullest extent permitted by law, the owners shall be responsible for all injuries, to persons or property, and shall indemnify and hold harmless the Village of Maple Park, its officers, employees, and agents from any and all claims, lawsuits, actions, costs and fees (including reasonable attorneys’ fees and expenses) of every nature or description, arising out of, resulting from, or connected with the exercise of authority granted by the requestor, which is the subject of this resolution. This obligation is binding upon the requestor, regardless of whether or not such claim, damage, loss or expense is caused in part by the act, omission, or negligence of the Village of Maple Park or its officers, employees or agents.

SECTION 2. The National Multiple Sclerosis Society has provided a comprehensive general liability policy and an additional named insured endorsement in the amount of \$2,000,000.00 general aggregate, \$1,000,000.00 per person, which has the Village of Maple Park, its officials, employees, and agents as insureds, and which protects them all from claims arising from the requested road closure. A copy of said policy and endorsement is attached to this document and marked as Exhibit B.
