THIS PROPOSED ORDINANCE WOULD, IF PASSEDK UPDATE CERTAIN PROVISIONS IN THE MAPLE PARK LIQUOR CONTROL ORDINANCE TO ALIGN WITH ILLINOIS STATE LAW REGARDING THE ABILITY OF VILLAGE TRUSTEES TO HOLD AN INTEREST IN A LIQUOR LICENSE UNDER CERTAIN CONDITIONS. IT WOULD ALSO UPDATE THE CODE TO FORMALLY IDENTIFY LIMITED LIABILITY COMPANIES (LLC's) AS BEING UNDER THE SAME RESTRICTIONS FOR CORPORATIONS WHICH HOLD LICENSES.
