# BOARD OF TRUSTEES MEETING MINUTES TUESDAY, JULY 5, 2016 7:00 P.M. MAPLE PARK CIVIC CENTER 302 WILLOW STREET, MAPLE PARK

#### 1. CALL TO ORDER

Village President Kathy Curtis called the meeting to order at 7:00 p.m.

Village Clerk Liz Peerboom called the roll call and the following Board members were present: Village Present Kathy Curtis, Trustee JP Dries, Trustee Kristine Dalton, Trustee Terry Borg, Trustee Higgins and Trustee Harris. Absent: Trustee Goucher.

Village Attorney Kevin Buick issued the oath of office to the new Trustee.

Chris Polloway from 420 Elizabeth Street talked about the noise from the industrial equipment coming from the business located behind their residence. Mr. Polloway advised that it has become a major quality of life issue, and asked about zoning of the property. He also asked if the Board knew what type of business they are operating. Mr. Polloway added that the property has a shabby appearance and makes it difficult for people to sell their property.

President Curtis advised that she and staff has been working with this issue since February and will push this out to the trustees for a solution.

Trustee Dalton asked that it would be more advantageous to run the aerators at night because of mosquitoes. Mr. Miller said that it doesn't really matter with mosquitoes. Mr. Miller also discussed the need to educate the public about mosquitoes.
