#### C. ORDINANCES

#### 1. ORDINANCE 2017-09 ADDITIONAL PARKING REGULATIONS

AN ORDINANCE AMENDING TITLE 11, CHAPTER 9; SECTION 11-9-3 "ADDITONAL PARKING REGULATIONS," OF THE MAPLE PARK VILLAGE CODE

This Ordinance updates the definition of recreational vehicles to align with the IL Compiled Statutes, redefines the rules for parking of recreational vehicles and adds a permitted address to the approved list.

Trustee Dries made a motion to approve Ordinance 2017-09 "Amending 11-9-3: Additional Parking Regulations," seconded by Trustee Harris.

Trustee Higgins said that he agrees that the village needs to be cleaned up. He said that if an approved surface is clearly defined the code can be enforced. He said that normally homeowner's associations would govern items such as these. He feels that the village has residents that go by the rules. He also distributed a map of an area in Maple Park.

Trustee Goucher said that he is concerned about the 7-day restriction. He was happy for the public that came out to talk about this ordinance. He wants an open dialogue with the residents.

Trustee Higgins went on about his opposition to the ordinance. Trustee Dalton asked Trustee Higgins if he wanted his property value to go up or down. Trustee Goucher asked if golf carts could be added. Mr. Buick recommended that the ordinance not be changed tonight.

Trustee Higgins advised that the number of people that have come out in opposition far outweigh the people that have come out in favor of it.

#### 2. **Ordinance 2017-15** Fences

AN ORDINANCE AMENDING TITLE 11 "ZONING REGULATIONS," CHAPTER 2 "GENERAL PROVISIONS," SUBSECTION 4 "ADDITIONAL REGULATIONS FOR UNIQUE USES,' A. "FENCES, WALLS AND HEDGES," OF THE VILLAGE CODE OF THE VILLAGE OF MAPLE PARK, ILLINOIS

This ordinance updates the corner lot setback, the size of a fence on a corner lot and the clarifies that a corner lot shall be considered to have two front yards.

Trustee Dries made a motion to approve Ordinance 2017-15 "Amending 11-2-4: Fences, Walls and Hedges," seconded by Trustee Harris. Motion carried by roll call vote. Aye: Shaver, Dries, Goucher, Harris, Dalton, Higgins. Nay: None. Absent: None. (6-0-0)

#### 3. ORDINANCE 2017-16 PREVAILING WAGE

AN ORDINANCE DETERMINING THE PREVAILING WAGE RATES AS OF JULY 2017 FOR CONSTRUCTION OF PUBLIC WORKS PROJECTS UNDER THE JURISDICTION OF THE VILLAGE OF MAPLE PARK

This ordinance determines the prevailing wage rates for construction of public works projects under the jurisdiction of the Village of Maple Park.

Trustee Dries made a motion to approve Ordinance 2017-16: Determining the Prevailing Wage Rates for July 2017 for Construction of Public Works Projects Under the jurisdiction of Maple Park," seconded by Trustee Goucher. Motion carried by roll call vote. Aye: Dries, Goucher, Harris, Dalton, Higgins, Shaver. Nay: None. Absent: None. (6-0-0)

#### **D.** MOTIONS

1. MOTION TO APPROVE THE QUOTE FROM 4 BROTHERS LANDSCAPING GARDEN & MAINTENANCE FOR A NOT TO EXCEED AMOUNT OF \$16,350.00 TO REMOVE VEGETATION FROM THE AREA AROUND THE WASTE WATER TREATMENT PLANT

This project was being required by the Illinois Environmental Protection Agency and will include taking out stones and cleaning up the grass; installing 325 feet of weed fabric; clean stones and install; Add 27 tons of stones (200 ft. between the 2 ponds, water overflowing); 27 tons of gravel to cover 200 ft/5 ft along the pond. This project requires an appropriation amendment.

Trustee Goucher made a motion to approve the quote from 4 Brothers Landscaping Garden and Maintenance in an Amount Not to Exceed \$16,350.00 to Remove Vegetation from the Area Around the Waste Water Treatment Plant," seconded by Trustee Harris. Motion carried by roll call vote. Aye: Goucher, Harris, Dalton, Higgins, Shaver, Dries. Nay: None. Absent: None. (6-0-0)

Public Works Director Mike Miller was concerned that he wasn't told about this. President Curtis said she would follow-up with Jeremy Lin.

### 2. MOTION TO APPROVE THE MAPLE PARK 2017 CRACK SEALING PROJECT IN THE AMOUNT NOT TO EXCEED \$19,490.00

This project was budgeted in an amount of \$20,000 and would include routing cracks to a depth of ¾" and a width of ¾" to provide a reservoir for sealant. This project includes Settlement Drive, Walnut Avenue and a small section of Broadway.

Trustee Higgins talked about areas in Heritage Hills that weren't' crack sealed last year.

Trustee Goucher made a motion to approve the Maple Park 2017 Crack Sealing Project in the Amount Not to Exceed \$19,490, seconded by Trustee Harris. Motion carried by roll call vote. Aye: Harris, Dalton, Higgins, Shaver, Dries, Goucher. Nay: None. Absent: None. (6-0-0)
